CALL TO ORDER

Chris Jew called the meeting to order at 6:30 p.m., and a quorum was met.

APPROVE OCTOBER 19, 2021 MINUTES

Roberta made a motion to approve the minutes as presented; Joli seconded the motion. There were no comments. Minutes as presented were approved unanimously.

REVIEW & CERTIFY MEASURE A PARCEL TAX EXPENDITURES FOR 2020-2021

Chris asked for any additional comments on the expenditure report. The Staff Team sent additional information to review one week prior to the meeting to address questions from the last meeting. Herbert asked if the breakdown of funds would be allocated similar to the budget? i.e. Salaries 85%. Chris said it does not have to align but it does reinforce how critical the personnel costs are. Herbert asked if funds would be allocated in the future to the CLIP program. Chris said the Board wanted to leverage the funds across the District. General funds are allocated based on a per student fund. Carol mentioned that the Parcel Tax was for specific things as printed on Annual Report and not for specialized programs. Joli asked if the report changed, 2021-2022 was accidentally pulled up. The 2020-2021 was then pulled up for reference.

Carol made a motion to certify the expenditures as presented; Roberta seconded the motion. No further questions were asked. Expenditures as presented were approved unanimously.

REVIEW & APPROVE THE ANNUAL REPORT TO THE COMMUNITY 2020-2021

Chris asked for any additional comments on the annual report. April mentioned that it looks much cleaner and there was unanimous agreement. Chris mentioned that the expenditures were aligned with the ballot language. Carol mentioned that it is much easier to read. There were no additional comments.

April made a motion to approve the Annual Report as presented; Carol seconded the motion. No further comments or questions. The Annual Report as presented was approved unanimously.

DISCUSS REPORT TO THE BOARD ON NOVEMBER 4, 2021

Roberta recommended April to present to the Board on November 4; April agreed. Tina will send a Zoom panelist invite to April for the Board Meeting.
